Mr. Valencia asked the Board of Trustees to either move his father into the crypt he originally purchased in 2012 or refund all the fees they had paid for his burial (\$6,606). Due to a cierical error the purchase in 2012 was not documented correctly, and the crypt had been resold in 2018. An offer was made to move both Gilberto and his wife so they could be side by side instead of over and under, but Mr. Valencia stated that moving his mother was not an option. Mr. Valencia was asked if he would except a refund of \$3,000 since a burial had been completed. He said no, since it was not in the crypt he wanted. MMSC to have the Trustees send the family that purchased the crypt in 2018 a second request, by letter, signed by the Trustees, asking to move their pre needs to different crypts at no cost to them so that Gilberto could be buried in the crypt he purchased in 2012.
